DAAC Committee Resumes Work in early October

The Dudley Area Advisory Committee (DAAC) was chartered over a year ago to make recommendations to the Board of Selectmen regarding the disposition of the property commonly referred to as Dudley Woods. After a spring and summer of no activity, the committee is scheduled to meet on Monday, October 9th to resume its discussions of a number of potential options. The goal would be to bring to the next town meeting any articles required to transfer land or take any other required actions consistent with its final recommendations. Whether to recommend the allocation of some of the parcel for the construction of affordable housing remains the major issue.

Depending on progress, an update on committee activities will be presented at our fall meeting.

Water Circulators Live On

Do you remember the solar-powered water circulators that until this year were deployed on the Pond? They were found to be ineffective against the milfoil weeds, so the Town sold them last Spring. Surface Water Quality Committee: 2012 Season-End Update

2012 MILFOIL - 23596 PLANTS thru 09/21/2012

AN INDUSTRIAL STRENGTH EFFORT – ALL TIME HAND-PULL RECORD The holy grail of sustainable management minimizing herbicide is deliciously close – but was hugely challenging this year. What a growing season - looks like 2-3 weeks longer at both ends! Milfoil loves that global warming.

For reference: In 2007 we did mechanical harvesting, 2008 we did a whole lake herbicide and in 2010 a spot treatment. This year we had part-time help from two college students to make, set, and remove marker buoys - but the real credit goes to the relentless Allison LaClaire & Ted Fiust. And it ain't over 'til it's over.

End of year conditions & the outlook for 2013

It's not pretty - fall is upon us and water temperatures are still way above 60° F - so the milfoil keeps growing & we keep pulling. We return to the same areas about every three weeks to pull a new crop of 3' tall plants. As the season extends, plants come up in new areas and deeper areas. As last year, we don't know yet if we will need herbicide to keep things under control or not - we think we can finish the season with at least as clean a pond as 2011. We won't make the herbicide call until spring of 2013 – so far, so good.

E-coil sampling at Mansion Beach – some good news

Lisa Newton did all the sampling this year - and we are grateful for her help. The Health Department now treats Mansion Beach as it does the Town Beach. We were well below the danger level and better than last year. Maybe those swans are driving out the Canada Geese?

Water Quality Sampling & Water Clarity

Toni Moores continued our 3x yearly water quality sampling - which hasn't changed much - still too much plant food in the water; but still not bad. Water clarity was low for much of summer while water was warmest – impeding the divers. In some areas and times under 3' (Braille diving). Jack Peter's measurements show improvement to 9' most recently at the deep hole.

Hooray: The Governor signed into law the Phosphorus Ban for fertilizers – except for some very limited situations. This will help.

STORMWATER – What's an MS4?

An acronym for *Municipal Separate Storm Sewer System* – a new body of EPA regulations for more urbanized areas (read: Cochituate) designed to improve handling of road and lawn runoff into lakes and ponds. Stormwater control at Dudley Pond is very poor - we have clogged catch basins on private roads, home construction clogging drains and rolling into the pond, some drainage structures that empty into the pond without much filtering, and street runoff flowing directly across Mansion Beach at times. The net result is plant food and road crud flowing into the pond.

We can and should do much better - and the new regulations may push us to making these improvements, and perhaps help fund them. SWQC is discussing possible improvements in stormwater and public access at Mansion Beach and other points.
