## Dudley Area Advisory Committee Final Report

After many months of meetings and deliberations, the work of the Dudley Area Advisory Committee (DAAC) was completed at a meeting held on June 17<sup>th</sup>. DAAC was formed by the Board of Selectman to come up with recommendations as to the best uses for 7.5 acres of town-owned land located in the Doran Road area.

In addition to accepting the final report of a study of the property by Tighe & Bond, the members voted on several proposals presented by the chairperson. A summary of those votes are as follows:

1. Rocky point to be transferred to the Conservation Commission for recommended passive use (9-0, passes)
2. All other land not under the jurisdiction of the Recreation Commission should be transferred to that commission for recommended passive use (7-2, passes)
3. A feasibility study should be initiated to evaluate technical and cost feasibility of a Distributed Wastewater Treatment Facility (DWTF) (9-0, passes); the committee recommended that if that study supports a DWTF as a desired outcome, the Recreation Commission would allow an easement for it (9-0, passes)
4. Parking should be provided for 2 cars at Rocky Point and 4 to 6 cars at another spot (9-0, passes)
5. Passive storm water treatment, if low cost, should be considered to divert storm water (9-0, passes)
6. Committee recommends no housing be built on the parcel (4-5, fails)
7. Recommendation for CPA funds be allocated to purchase 3 affordable dwellings in the vicinity of the parcel (6-3, passes)
8. Recommendation to set aside a parcel for future development of four housing units (5-4, passes)

- The 3 Overall best times Female Winners were all in their 40's, yet they beat out all other ages groups, including those in the 3 younger categories.

## Surface Water Quality Committee: 2013 Season-End Update

Tough Year – we won – thanks for the DPA's 25% financial match. Our strategy for herbicide minimization and hand pulling continues effective.

We last applied spot herbicide in 2010 – and this year we treated by airboat 18.9 acres with triclopyr at a concentration allowed by EPA in drinking water reservoirs. We dammed the outlet to protect town wells from herbicide – we removed the sandbags at the end of August and the pond dropped 9".

Thru July 31<sup>st</sup>, Allison & Ted's crew hand pulled 44,446 plants by the roots.

The town spent \$36,189 and DPA contributed \$8,511. Roughly another \$2,000 will be spent by year end on year end pulling and survey, and contractor holdbacks.

Although we had a good summer for recreational uses, Allison has seen some new plants pop up.

We note with trepidation the advance of clusters of tape grass (aka eelgrass, water celery, *Vallisneria Americana*). This year we removed end-of-season floating clumps (see picture to the right) but it's not part of our Order of Conditions – so we're not allowed to remove it at this time.



Thanks to Lisa Newton for taking weekly samples for e.Coli at Mansion Beach and the Health Department for processing them – we exceeded the state limit once this summer and shut the beach briefly. From our plastic Wile E. Coyote to the new barricade of pinwheels – we are discouraging ducks, geese, and swans from coming up on the beach. PLEASE DON'T FEED THEM.

Thanks to Allison for her endless efforts & the splendid collection of submerged fire extinguishers, trash, bongs, toaster ovens, etc. which she hauled up (then hauled to the DPA Run/Walk for all to see). The engine block she spotted is still down there – swimming with the monster turtles.
