Dear DPA Members,

Dudley Pond is a real treasure for all of us to enjoy, and in these times of stress the opportunity to seek peace and pleasure just outside your door is more needed than ever. The strength of our association has been, and continues to be, essential to the health of Dudley Pond.

While we are all enjoying Dudley Pond at it's best, milfoil monitoring and control activities will continue. Having got through the difficult process of sonar application, attention now turns to doing all we can to suppress re-growth as long as possible. As you enjoy, please be vigilant and promptly report any milfoil sightings to Mike Lowery (lowery.mike@gmail.com). We very much hope that vigilance and action now will delay the day when we will once again have to begin the arduous and expensive herbicide application process.

After years of focus on the pond itself, there is growing interest in the ecological impact of the land around the pond. Many believe that fertilizer runoff, leaking septic systems, storm runoff and other land-based sources of nutrients are contributing significantly to the re-growth of milfoil by overloading the pond with nutrients. It is likely that one or more town boards will begin seriously considering how to control one or more perceived sources of nutrient loading. If you have strong feelings one way or the other on this, please watch for opportunities for public discussion.

During this summer we will enjoy the Pond at it's best, and surely we have earned that enjoyment. I hope everyone is able to take a good measure of time pursuing their favorite activities. I also hope everyone finds some small measure of time, whether on land or in the pond, to take actions that show your care for the health of Dudley Pond.

The 2009 fluridone treatment was the longest and strongest them. So far we have seen little significant difference between funded divers pulled 12,062 root crowns – in a first-in-the-US attempt to limit re-growth.

Nothing visible vet – We'll keep looking.

In late March, Ted Fiust took advantage of good lighting and calm waters and surveyed all the troublesome areas by kayak nothing so far. In late April, as the waters warm, we plan an underwater survey - duplicating the areas surveyed post- street and lawn runoff and leaching from the many septic treatment 2008. We will be checking every couple of weeks. s y s t e m s We expect some re-growth 2009; more in 2010.

And when we find it coming back?

We have three control areas where root crowns were not pulled. When re-growth is apparent we will compare pulled areas to our control areas. Dudley Pond might be able to put another tool in the milfoil control tool box if post-herbicide root-crown pulling really helps.

In 2009 SWQC will seek DPA's support and input on municipal regulations governing septic practices and lawn chemical practices, two major contributors to Dudley Pond's nutrient budget. Cutting back nitrogen and phosphorus reaching the

Report any milfoil you see to lowery.mike@gmail.com please make careful note of the date and where you spotted it. When you are on the pond, stay on the alert and look into the water. Avoid using lawn chemicals. If you must fertilize, please use slow-release, low phosphorus products and keep them 3' away from roads and driveways. Have your septic system pumped every three years or more frequently if your system is small, old, or you have more than four persons in your home.

Report clogged or failed catch basins to the DPW. If you have a pontoon boat, volunteer it or use it yourself for milfoil 'scouting'
